This guide aims to help you by highlighting the main elements of the BRE safety, health, environmental, fire and emergency procedures.

It must be read and complied with by all contractors working within BRE.

GENERAL

The BRE Project Manager must discuss the scope of works including all relevant risk assessments and method statements with all operatives involved in the works. This discussion is recorded on the Contractor / Client Site Induction & Authorisation Form (CSI&A), a copy of which is required as part of the signing-in process.

You may not work until:

- 1 You have signed a copy of the CSI&A.
- 2 The BRE Competent person has received a copy of the CSI&A from the BRE Project Manager.

You must:

- 1 On arrival, sign in at the designated location noted on the CSI&A.
- 2 Display a valid identity pass at all times (issued on arrival)..
- **3** Comply with the BRE health, safety, environmental, fire and emergency procedures.
- 4 Fully understand the risk assessments and method statements produced for the works and comply with them.
- 5 Read this leaflet and comply with its requirements.

The BRE Project Manager will advise on Welfare facilities available to contractors. If permission is given to use the BRE Restaurant, soiled clothing and dirty footwear must be removed before entry.

WORKING SAFELY AT BRE

You must:

- 1 Be competent to safely carry out the work required.
- 2 Comply with current statutory safety regulations.
- **3** Comply with all warning signs and health and safety procedures.
- 4 Confine your activities to areas defined by the CSI&A.
- **5** Ensure that you do not put yourself or others at risk from your activities.
- 6 Take adequate fire precautions and be aware of the actions to be taken in the event of fire or other emergency.
- 7 On completion of the works, remove all equipment and waste from the site immediately.

You may not:

- 1 Use portable electrical equipment operating at greater than 110V for any work in laboratories, test facilities or for any construction/building maintenance work.
- **2** Leave any unattended equipment operating, without prior approval of the BRE Competent person.
- **3** Use any BRE tools or equipment.
- 4 Use radios or personal audio devices.
- **5** Smoke within any of the premises.
- 6 Drink or be under the influence of alcohol or drugs on the site.

SECURITY

BRE Watford is covered by 24-hour manned security and recorded CCTV. Contractors must enter and leave the site by the main gate only. Contractor access to the site is 0800 to 1700 Monday to Friday. Access/work outside these hours must be authorised by the BRE Project Manager. Please display your pass at all times. Permits To Work can be issued by the BRE Facilities group. No work can be undertaken on any of the below without prior consultation with Facilities.

Work categories:

- 1 Works on, or near asbestos-containing material.
- 2 Works in confined spaces.
- **3** Excavations.
- 4 Works on electrical services.
- 5 Works on non-domestic gas services.
- 6 Hot works.
- 7 Works on lifts.
- 8 Works on pressure systems.
- **9** Works on equipment containing Ozone Depleting Substances.
- **10** Works on suspended access systems.
- 11 Hazardous or restricted areas.

IMPACTS ON THE ENVIRONMENT

You must:

- 1 Identify environmental risks associated with your work and manage these competently, as well as including them in your risk assessment and method statement (RAMS). Pay particular attention to your approach to effective waste management.
- 2 Seek further guidance from either the BRE Competent person or the BRE Environment Manager if you are unsure of the environmental risks of your work.

FIRST AID

It is expected that contractors will supply appropriate First Aid cover however in a real emergency situation we will be pleased to assist with any First Aid that we have available. To summon First Aid call 3333 from an internal BRE phone or 01923 664333 from a mobile, these numbers should also be used if you require an ambulance.

PERMIT TO WORK

Fire alarm tests:

The fire alarm systems on all buildings are tested every Tuesday morning. This is signalled by a short sounding of the alarm bells/ sirens, providing this stops in a few seconds take no action.

If you discover a fire:

- 1 Break glass on nearest call point. Shout 'fire' for all people in the immediate area.
- **2** Leave the building by nearest safe exit.
- 3 If it is deemed a serious/life threatening situation call 999.
- 4 Dial 3333 from a safe location using a BRE internal phone or 01923 664333 from a mobile and describe the emergency and its location

On hearing the fire alarm:

- 1 Switch off electrical equipment and machinery.
- 2 Evacuate the building closing doors behind you.
- **3** Report to the designated assembly point.

If you discover a gas leak, chemical spillage or suspect package:

- 1 Shout 'Gas leak!' or 'Emergency!'.
- **2** Do not press the fire alarm button or use any electrical equipment or mobile phones.
- **3** Leave the building by the nearest safe exit.
- 4 Dial 3333 from a safe location using a BRE internal phone or 01923 664333 from a mobile and describe the emergency and its location. Accidents, incidents, near misses must be reported to BRE Project Manager and BRE Group H,S&E, details must be recorded in BRE accident book.

EMERGENCY CALLS

In the event of a fire or serious accident that is deemed a serious/life threatening situation call 999 from a safe location. Then dial 3333 from a BRE internal phone or 01923 664333 from a mobile. This will invoke BRE's emergency procedures.

HAZARDOUS AREAS

Laboratories at BRE present particular hazards for working. These areas will have prominent signs displayed at the point of entry.

- Blue signs give compulsory instructions. You must obey these signs.
- Yellow signs are warnings of a particular hazard. Check with the BRE Project Manager prior to working in these areas to ensure the hazard has been covered in the risk assessment for the works you are doing.

Each day before starting work in any laboratory, operatives must ensure the BRE Project Manager has given approval for that day's work.

DRIVING AND PARKING

Access roads can be narrow, with traffic calming humps and are used by pedestrians who might not be thinking about traffic. Drivers of all vehicles will be expected to follow the Highway Code and always drive with due care and attention to other road users.

The site speed limit is 15mph and must be observed.

Forklift trucks operate on this site and must have priority over all other road users, please give way to them. Never overtake and become a danger to yourselves and others.

The law does not allow, and neither does BRE, the use of handheld mobile phones whilst driving on site. BRE regards this as misconduct.

PARKING

- BRE has a reverse parking policy. Please park facing out.
- Please do not park on any double yellow lines, at any time.
- Damage to any paving etc caused by illegal parking or deliveries will be charged back to your employer.
